So, what's new?

A message from Managing Partner Ira Sherman



All of our clients and followers of our newsletter and website are aware that the soul of the law firm, and its primary driving force, is to aggressively and creatively represent individuals injured because of the carelessness of others. As many of you know, we have dedicated ourselves to representing individuals irrespective of the severity of the injury—whether it is "whiplash" or severe traumatic brain injury. Each and every client is represented with the same energy and drive to obtain the greatest amount of compensation available under the law. Many of you know that our clients are frequently involved in automobile accidents, slip and falls, excessive force by police or hired security, truck and tractor-trailer accidents, and accidents that arise out of the negligent operations of swimming pools, group homes, and other places where we place our trust in others who care for our children or other loved ones.

However, several clients have asked, "So, what's new?"—meaning what are the new developing areas of the law that we are now focusing on. The focus on individuals who sustain brain injuries is always evolving. That is not because concussions and brain injuries are new; it is because the public has become very aware of the dangers of concussions and head injuries. We know about head injuries because of the NFL settlement, from our own family experiences, and that of young men and women returning from active duty with

posttraumatic stress disorder. Accordingly, individuals involved in accidents are now more willing to talk about their "forgetfulness," changing moods, loss of taste and smell, and many things that they so much enjoyed before the accident took place. Now, D.C., Virginia, and Maryland all have various forms of "Youth Concussion Protection" acts. Each of these laws has the goal of protecting our children who engage in sports from the effects of traumatic brain injury. "When in doubt, take them out" refers to the new requirement that when a concussion is suspected, the child must be removed from the game and not be permitted to return to play until a certified health professional allows it. The failure of organizations and individuals to adequately protect our youths from sustaining concussions or responding appropriately by removing them from the game when a concussion is suspected can result in compensation for the harm caused by the carelessness of the supervisory staff.





BILL COSBY CASE PROCEEDS TO DISCOVERY

Many of you who follow the firm news know that partners Joseph Cammarata and Ira Sherman, and associate Matthew Tievsky, are representing seven women who sued Mr. Cosby for defamation. These women claim that Bill Cosby has "branded them liars" as a result of his public denials of their claims that Mr. Cosby sexually assaulted or abused them.

The law firm successfully defeated Mr. Cosby's attempt to have the case dismissed. We also overcame Mr. Cosby's attempts to limit our ability to take the deposition of Mrs. Cosby. The case is currently moving forward in the discovery (fact-finding) stage. Mr. Cammarata took the deposition of Mrs. Cosby and the depositions of two of Mr. Cosby's former lawyers who were involved in defaming our seven clients.

Mr. Cosby has also been criminally charged in Pennsylvania as a result of his alleged assault of another victim. In light of this pending criminal case, we have not been allowed to take Mr. Cosby's deposition because any testimony he gives in the defamation case may incriminate him with respect to the criminal charges pending against him.

We look forward to presenting our clients' cases to a jury. Our clients are resolute in their conviction that after a jury trial, their good names and reputations will be restored.

TOP 10 SWIMMING SAFETY TIPS

With summer upon us, we always like to remind our clients how important it is to keep their children safe in the water. Unfortunately, the law firm has handled many drowning and near-drowning cases caused by inadequate supervision of swimmers or poor safety procedures and protocols. Here are some reminders on how to stay safe while in the water:

- **1.** Ensure your child is swimming in designated areas supervised by lifeguards.
- 2. Always have your child swim with a buddy.
- 3. Never leave your child unattended near water.
- 4. Do not trust your child's life to another child.
- If your child can't swim, or doesn't swim well, have them wear U.S. Coast Guard approved life jackets or flotation devices.
- **6.** If you have a pool, ensure that it is secured with appropriate barriers.
- **7.** Do not get distracted when you are supervising children around water. Seconds can count in saving a child's life.



- **8.** Remove toys from the pool when not in use. "Noodles" and other blow-up toys and rafts can be very tempting to other children. You don't want a child to lean over the edge to get a toy and fall in the water, or for a less experienced swimmer to use a toy that puts them in a dangerous situation.
- 9. Make sure that you have all appropriate equipment nearby. For example, you should have reaching or throwing equipment, a cell phone, life jackets, and a first-aid kid readily accessible near the water. Be prepared to call 9-1-1 or other local emergency number, if necessary.
- **10.** Follow safety signs posted at the pool or beach, and make sure your child knows the importance of following directions.



PARTNER ALLAN M. SIEGEL INVITED TO SPEAK AT NEW JERSEY AND D.C. SEMINARS
